### Dog Fouling in the Village

The revised dog control order, for the Bush lane playing fields, will come into force in the new year, after the fencing has been erected around the area allocated for the exercising of dogs. A copy of the Order and an associated map will be posted on the Community notice board, opposite the Cenotaph and on the Council's web site, nearer to the implementation date.

Briefly, the Order will:-

1. Allow dogs to be exercised off the lead in an area to the south of the Rawstone centre car park. This area will be fenced off to make it safer.
2. Exclude dogs from the playing areas to the north of the car park, except for a two metres strip around the perimeter of this field, where the dogs must be on a lead.
3. Make it an offence not to pick up after your dog has fouled, in either of these areas and the car park. Failure to comply with the Order will result in a fixed penalty fine of £75 being issued.

## Civic Services

The Council would like to thank the public and particularly the children of the village, for their continued support at the Remembrance Sunday and Tree lighting and Carol services that were recently held at the Cenotaph.

The Council would like to point out that this year they tried a new procedure to ensure all the children and officials had sufficient space, within the Cenotaph gardens, before the public were allowed in. This procedure worked well and it is hoped that those wishing to enter the Cenotaph garden did so after the guests had taken up their places.

### Additional burial ground

The Parochial Church Council has asked the Parish Council if they will provide additional burial ground, as the existing graveyard has limited space available for burial.

From the land owned by the Parish Council, the Memorial gardens, adjacent to the Bowling green, has been identified as the most suitable area.

However, the Parish Council are currently obtaining costs required to re-design this area to make it suitable for a burial ground. These include; legal cost for transferring the land to the PCC, a more secure structure around the perimeter, easy access from the existing graveyard, and an alternative entrance to the Bowling green.

It is hoped that these costs will be available by the middle of next year and at that point the Council will make a decision on whether this area could be reallocated as a burial ground.
