Freckleton PC supports this plan in respect of the proposed utilisation of a renewable energy source.

However, the Parish Council is deeply concerned with the possible impact of the associated "environmental enhancement" which is aimed at attracting birds to the Ribble estuary marshes and salt flats. The site chosen is extremely close to or under the approach path for aircraft that utilise Warton airfield. Such development could represent a significant increase in the risk of "Bird Strike" to such aircraft, and the PC is extremely sensitive to the possible consequences of such events. This can include loss of an aircraft and of life, to both the crews and personnel on the ground who live or work in the area. From the presentation given by the applicant representatives, it is clear that this aspect has yet to be considered in any depth.
